MEMORANDUM FOR ALL 8 FW ISOLATED PERSONNEL

SUBJECT: 8 FW Isolation ROEs

1. You have been determined to be actively infected with COVID-19. Per USFK memorandum, "Delegation of Authority for Component Commanders to Allow for On-Base Isolation in Living Quarters" dated 20 Sep 2021, Kunsan AB is authorized to allow personnel infected with COVID-19 to isolate on-base in living quarters that do not share a bathroom or designated isolation rooms. Therefore, I order you to comply with all isolation requirements. Compliance with these requirements is necessary to ensure the safety and readiness of our force.

2. I order you to comply with the following requirements:

- a. DO NOT leave your isolation location unless there is an immediate threat or concern to your life or safety. The only other time personnel may leave their room is for COVID-19 testing, to do laundry and/or trash from 1000-1200 on Monday, Wednesday and Friday or outdoor time daily from 1300-1500. If there is any notification to evacuate your isolation location (fire alarm, sirens, knocking on doors, etc.) your immediate safety is the number one priority. All isolation members should don their mask and a reflective belt (if readily accessible), immediately evacuate the facility, and report to their designated isolation emergency rally point (see attached map).
- b. DO NOT have physical contact with any individuals. Maintain a minimum of 6 feet from all personnel. Don your mask and a reflective belt when you leave your room for COVID-19 testing, laundry, trash takeout or outdoor time.
- c. STAY in your isolation location until released. DO NOT leave your isolation quarters until instructed by your squadron leadership (SQ/CC, SQ/DO, SQ/Sup or SQ First Sergeant).
- d. If you are experiencing potentially life threatening symptoms, please immediately call 911 or 063-470-0911 from a Korean cellular phone. If your symptoms require attention, but are not life threatening, you may call the COVID Isolation Medical Officer on Duty Call Line at 010-3658-0752 for help.

3. This is a punitive order. During the Public Health emergency, violators of procedures, protocols, provisions, and/or orders detailed in this memorandum may be charged with a crime under Article 84, Breach of Medical Quarantine, Uniform Code of Military Justice (UCMJ); Article 92, Failure to Obey an Order or Regulation, UCMJ; and/or 42USC Section 241d, punished with a fine up to \$1,000, debarment from all USFK installations for two years, imprisonment for not more than one year, dishonorable discharge, and/or all of the above. This order is in effect to protect the force, to protect you, and to protect the mission.
