UNTIL RECEIPT OF DAY 12 NEGATIVE PCR TEST RESULT, VACCINATED ARRIVALS MUST



- ADHERE TO USFK ARRIVAL PROCEDURES AND MAINTAIN CORE TENETS
- ► RECEIVE DAY 1, 6 & 12 NEGATIVE PCR TEST RESULTS
- MUST REMAIN IN APPROVED QUARANTINE FACILITY UNTIL RECEIPT OF NEGATIVE DAY 1 PCR TEST RESULT
- ► FOLLOW ALL HPCON RESTRICTIONS AND MASK WEAR GUIDANCE ON-INSTALLATION
- FOLLOW ALL USFK AND ROK RULES & REGULATIONS OFF-INSTALLATION
- ► IF AN INDIVIDUAL DISPLAYS SYMPTOMS OF COVID-19, THE INDIVIDUAL MUST IMMEDIATELY GET TESTED AND REMAIN QUARANTINED UNTIL TEST RESULTS COME BACK

LIMIT OFF-INSTALLATION ACTIVITIES TO MISSION ESSENTIAL REQUIREMENTS AND TRAVEL TO/FROM DOMICILE - MAXIMIZE USE OF ON-INSTALLATION SERVICES

MISSION ESSENTIAL ACTIVITIES ARE LIMITED TO THE FOLLOWING:

- ALL DUTY ACTIVITIES
 - including combined training and exercises on USFK & ROK MND installations
- Public transportation only to accomplish MISSION ESSENTIAL activities
- ► HEALTH, LIFE AND SAFETY ACTIVITIES
 - emergency services, hospitals/health care providers/pharmacies, child care, gas stations, banks/money exchange/realtor
- PURCHASING FOOD, CLOTHING AND ESSENTIAL NEEDS at retail stores, convenience stores, grocery stores, and markets (indoor malls & department stores prohibited)
- ► TAKE-OUT, DELIVERY AND DRIVE-THRU FROM RESTAURANTS
- **► LODGING IN APPROVED LOCATIONS**
 - lodging location must be pre-approved by USFK, GOVT, or Component Commander
- OUTDOOR HIKE, WALK, BIKE, RUN (FOLLOW ROK RULES ON GROUP SIZES)



All personnel must minimize these activities as much as possible. Only the activities listed may be conducted off-post.

All other activities are prohibited, unless an 0-6, or civilian equivalent, has granted an exception to policy.
