REMARKS		
<p>Effective 25 July, IAW FRAGO 128 to USFK OPORD 20-19, this directive mandates a Restriction of Movement for travelers arriving/returning from locations outside of the Korean peninsula, regardless of vaccination status. IAW 7 AF guidelines, a Working Restriction of Movement (ROM) is authorized:</p> <ol style="list-style-type: none"> 1. All Kunsan personnel (military, GS, and contractors), as well as dependents with SOFA status, are authorized a Working ROM. Members may travel to and from work to perform mission essential duties, as deemed necessary by their leadership. <ol style="list-style-type: none"> a. <u>Movement off-installation is prohibited</u> unless traveling between domicile and duty or in the event of a medical emergency or threat to safety. b. Members must wear a mask until negative Day 1 test results are received. c. Members must restrict their movement until negative Day 1 test results are received. 2. Mission essential ROM activities outside of work include the following: <ol style="list-style-type: none"> a. Food Procedures: Vaccinated members may take out food from any of the on-base facilities (DFAC, Club, BX Food Court, The Tavern, etc.) or pick up supplies at the Commissary. b. Medical and Pharmacy Procedures: Medical appointment and Pharmacy pick-ups are authorized. c. Fitness Procedures: Personnel are authorized to workout outdoors. Members must maintain social distancing protocols. Indoor gym use is not authorized. 3. For inbound personnel, the COVID wing tracker will be updated no later than 7 days prior to arrival and will include all required information (https://usaf.dps.mil/sites/kunsan/8FW/COVID-19/Lists/Inbounds/Medical%20Tracker.aspx) <ol style="list-style-type: none"> a. On Day 1, members will report to the 8 MDG COVID Testing CONNEX for a COVID-19 PCR test. 4. Transportation arrangements may include the following: <ol style="list-style-type: none"> a. Privately owned vehicle (POV). b. Government owned vehicle (GOV) or Government contracted bus transportation (i.e. Wolf Pack Wheels) c. Public transportation in accordance with ROK policy. 5. Members will comply with all ROK mask wear guidelines when off-installation.
