REMARKS:

IAW FRAGO 119 to USFK OPORD 20-19, the 7-day mandatory quarantine has been removed for all SOFA personnel who are fully vaccinated. This action rescinded SSD 21-18 and 21-19:

1. ROK definition of “fully vaccinated”, individuals are considered “fully vaccinated” and exempt from quarantine under the following conditions:
 - a. The individual has completed a single-dose or two-dose primary COVID-19 vaccine series within the last 14 to 180 days, or:
 - b. The individual has completed a primary COVID-19 vaccine series and received a booster dose.
2. Personnel who are not fully vaccinated will complete a mandatory 7-day quarantine when arriving/returning from overseas.
 - a. Personnel who are not fully vaccinated may receive an ETP from their Group/Squadron Commander to enter working ROM but any off-installation activities are strictly prohibited.
3. All personnel arriving to Kunsan will receive a COVID test on Day 1 and Day 6/7 at the 8 MDG COVID Testing CONNEX.
 - a. Personnel who are fully vaccinated IAW para 1 are **not** required to restrict movement while awaiting results of the Day 1 PCR test.
 - b. Personnel who are not fully vaccinated but granted an ETP are **not** required to wait for the results of the Day 1 PCR test in order to enter working ROM.
4. For all inbound personnel, the COVID wing tracker will be updated no later than 7 days prior to arrival, and will include all information required in the COVID wing tracker (<https://usaf.dps.mil/sites/kunsan/8FW/COVID-19/Lists/Inbounds/Medical%20Tracker.aspx>).
5. Starting 1 April, the use of public transportation from the airport is authorized for fully vaccinated personnel. The 8 FSS Kunsan-Incheon Airport Bus will continue as scheduled.
