<p>1. On 11 April, 2021 at 0600L USFK transitioned to HPCON Bravo. It is critical that all members of the Wolf Pack remain vigilant and continue to adhere to the guidelines outlined in this directive. This SSD covers approved activities and travel within HPCON Bravo. This guidance is IAW USFK OPERATION ORDER 20-19 FRAGO 70. This SSD supersedes SSD 21-1 Change 6 and SSD 21-2 Change 5.</p> <p>2. In order to protect the Pack, this directive must be followed by all military personnel, family members, US and Korean National civilian employees, DoD contractors, retirees, and any other persons with access to Kunsan Air Base. In addition to this SSD, please visit https://www.kunsan.af.mil/news/coronavirus-disease-2019 for the mostcurrent COVID-19 information and guidance.</p> <p>3. Self-Monitoring - Feeling sickly? Leave quickly! (GO HOME, DO NOT GO TO THE MEDICAL CLINIC)</p> <p style="margin-left: 20px;">a. Personnel identifying as sick will immediately return to their residence and contact the Kunsan COVID Symptom line at 010-3658-0752 during duty hours.</p> <p style="margin-left: 20px;">b. For after hour care or immediate life threatening medical emergencies dial 911.</p> <p>4. On-Base Activities: All on-base U.S. facilities and services are open.</p> <p>5. Off-Base Activities: Bars and clubs remain off limits to unvaccinated personnel and are defined as any establishment whose primary purpose is to serve alcohol or requires patrons to be 19 years of age IAW USFK and local ROK policies. Fully vaccinated personnel only are allowed to attend bars and clubs, except for those in Seoul/ Area II. Bars and clubs remain off limits in Seoul/Area II. Additionally, Saunas, Bathhouses, Karaoke rooms, and establishments that restrict entrance to adults only, remain off limits. Off-installation gyms require O-6 commander approval.</p> <p>6. On Peninsula Travel: Public transportation is authorized and personnel are permitted to stay at accommodations on or off base. When traveling across the peninsula it is the responsibility of the member to review local government's social distancing levels.</p> <p>7. Off Peninsula Travel: Travel outside of the Republic of Korea is authorized IAW the 8 FW Leave Policy.</p> <p>8. Mask Wear:</p> <p style="margin-left: 20px;">a. Fully vaccinated USFK personnel are not required to wear a mask on USFK installations except in facilities where it is explicitly required for entry as determined by the Base Commander. Examples of these facilities include visitors to the 8th Medical Group Clinic and all ROKAF-owned facilities.</p> <p style="margin-left: 20px;">b. Non-fully vaccinated personnel must wear a mask in all DoD installation facilities IAW the Deputy Secretary of Defense memorandum <i>Updated Mask Guidelines for Vaccinated Persons</i> dated 13 May 21. acceptable colors worn while in uniform include tan, black, white, brown, blue or olive drab. Small unit patches or insignia can be displayed on either side of the face mask, not to exceed 2 inches by 2 inches in size.</p> <p style="margin-left: 20px;">c. Off-installation, all active duty service members, DoD employees, KN civilian employees, contractors and dependents must wear a face mask IAW Republic of Korea (ROK) laws and guidelines regardless of vaccination status. The only authorized masks for off-base wear are reusable cloth masks or valveless medical/surgical masks.</p>
