- 6. Unit sanctioned gatherings of 10 or more people on Kunsan AB, whether they are indoors or outdoors, will be approved by the squadron commander. All indoor gatherings, as previously defined, require mask wear.
- 7. Squadron commanders will enforce existing indoor mask wear policy consistent with DoD Force Health Protection Guidance. Commanders retain authority to add additional mask wear requirements within their respective unit areas.

- 9. This order is issued pursuant to my authority as the installation commander and my continuing declaration of a Public Health Emergency (PHE). Any military member who refuses to obey this order and its restrictions may be subject to punishment under the Uniform Code of Military Justice (UCMJ). Those not subject to military law who refuse to obey or otherwise violate the foregoing restrictions may be denied installation access or be barred from the installation for a period up to two years.
